- b. You may mark the ballot with your vote [YES in favor] OR [NO against] for each amendment.
- c. You may vote for all, some, or none of the amendments
- d. You must sign and date the ballot
- e. If mailed, your ballot to the Richmond Amateur Telecommunications Society must be received by the Secretary at the PO Box prior to 11:00 AM, April 29, 2022 which is the last posting to the box prior to the meeting at 10am, April 30, 2022.
